Motion by Danberry, support by Rosenbaum to revise the August 12 minutes and strike, "railing," from the improvements to the Stone School. Motion Carried 5-0.

Mr. Wolff is gathering information and quotes for filtration improvements to be made to the drinking water fixtures on campus. As of now the district will be required to have a plan about how it will manage drinking water fixtures by January of 2025
